RULES

- 1.1 The event will be governed by Winter Windsurfing Rules 4 (WWR4) and the Racing Rules of Sailing – Windsurfing Competition Rules (WCR).
- 1.2 The Notice of Race (NOR).
- 1.3 The Sailing Instructions (SI) issued during and at event Venue. SI may be altered at skippers meetings on distance.
- 1.4 Official site for information and results is www.winterwindsurf.com. The WWR4, NoR and SI will be available at Official notice board.
- 1.5 Competitors shall attend the opening & closing ceremonies including the prize giving.

2 RACE FORMAT

- 2.1 The Championship shall be a double discipline, *course racing and slalom* “open entry” event for Sailboards and Wings.
- 2.2 Competitors shall race a maximum 7 in course and 25 in slalom race series.
- 2.3 One Course and three Slalom races are required to validate the Championship.

3 DIVISIONS

For divisions set according WWR4 every result will be calculated by making extraction from overall results without recalculating scores.

5 REGISTRATION

- 5.1 Eligible competitors may download Entry Form at www.winterwindsurf.com, fill out and send to wweo2014@gmail.com.
- 5.2 The following shall be presented upon registration:
 - Original Entry Form – *pre-entries will be given their completed form 1 to check and sign at registration;*
 - Evidence of valid third party insurance;
 - Proof of age;
 - Parental/legal Guardian Assent – *for those under age of 18;*

- Medical Treatment Permission – *for those under age of 18 or on their parents medical insurance policy.*

6 FEES

- 6.1 The required entry fee: is 70 euro; except Youth entry fee is 50 euro.
- 6.2 Entry fees can be paid with a bank transfer to „Vindserfinga Klubs 360“ account in Swedbank LV73HABA000140J037602 or at registration in cash (euro).
- 6.3 Late entries received at registration will be surcharged 20 euro.
- 6.4 Fees include participation in the event, ceremonies, lunch during competition days, Special edition WWEO2014 T-shirts will be given to all competitors, who paid Entry fee before February 23.

7 PRIZES

- 7.1 The first three competitors of each properly constituted division of WWEO 2014 will be awarded with medals and diplomas. Additional prizes may be awarded from sponsors.
- 7.2 The first man and woman in Course race will be declared - **“2014 Winter Windsurfing Course European Champion”**.
- 7.3 The first man and woman in Slalom will be declared - **“2014 Winter Windsurfing Slalom European Champion”**.

8 OFFICIAL CEREMONIES

Competitors are requested to attend the event’s social functions; however, the organizing authority may refuse entry to those whose standard of attire is not commensurate with the occasion. **Prize winners may forfeit prizes for non attendance at the prize giving ceremony.**

9 DISCLAIMER OF LIABILITY

Competitors participate in the event entirely at their own risk. The organizing authority or any of their officials or representatives or the sponsors or their officials or representatives will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the event.

10 INSURANCE

Each participating competitor shall be insured with valid third party liability insurance with a minimum cover of 300,000 euro per event or the equivalent.

11 ADVERTISING

- 11.1 Sailors may be required to display advertising chosen and supplied by the organizing authority. ISAF Regulation 20 ‘Advertising Code’ shall apply.
- 11.2 Event branding shall be worn at all times when afloat, and as requested by the organizers during media interviews and during the prize giving.

12 RIGHT TO USE NAME AND LIKENESS

In registering for the event, competitors automatically grant to the Organizing Authority the right in perpetuity to make, use and show from time to time at their discretion, any motion pictures, still pictures and live, taped or filmed television

and other reproduction of them, taken during the period of the event, for the said Event as defined in the Notice of Race and Sailing Instructions in which he/she participates without compensation.
